ASAC Monthly Credit/Debit Card Billing Information

Initiation of Recurring Payment Option

ASAC offers automatic monthly billing directly to a member's VISA, Discover, American Express or MasterCard credit or debit card. A member may exercise the recurring payment option by completing ASAC's Authorization for Credit/Debit Card Billing form and returning the form to ASAC. Upon receipt of the authorization, monthly payments will be charged to your card beginning with the current month. On the 1st day/business day of the payment option selected, ASAC will debit your credit/debit card with the dues charge per the option selected and a small program fee.

Changing Recurring Payment Option

If you would like to change your Monthly Credit/Debit Card Payment Option including, for example, making a change from one credit/debit card that was initially selected to another credit/debit card, you must authorize the recurring payment with the new credit/debit card by completing a new form. The change will not go into effect until the billing cycle after the new form is received. Your previously approved Credit/Debit Card Payment Option will be used until the new option goes into effect.

Recurring Payment Failure

If your recurring payment is declined, your Credit/Debit Payment Option will be removed and ASAC will invoice you for the remaining portion of your annual dues. ASAC may restrict your ability to use the payment method that was declined (e.g., credit card) for a period of time.
