Monday morning, March 15 and it looks and feels like Colorado this morning. Snowfall always slows things down and brings a hush to our busy lives. A weekend of watching the snow fall and the snow pile up is good for the soul.

If you live in Colorado, you need to know a few snow facts. Types of snow, there are four: snowflakes, hoarfrost, graupel and polycrystals. And there are five types of snow fall: blizzard, snow squall, blowing snow, winter storm and snow flurry. There you have it, enough information that you can keep up with any meteorologist.

This week is a big work at ASAC, HB21-1167, Private Construction Payments, reducing private retainage to 5% takes a first step in becoming law. We will be testifying before the House Business Affairs and Labor Committee Thursday, March 18 in the morning. Watch your inbox. You will be receiving a call to action asking you to contact members of the House Business Affairs and Labor Committee asking for their support of HB21-1167. We have made it easy for you to participate. We use a program called Voter Voice, a couple of clicks and your message has been sent.

Why is it important to reduce private retainage to five percent? Did you know that businesses are required to pay taxes based on the percentage of their completed work, regardless of whether they have been fully compensated due to retainage withholding; effectively paying taxes on money they have not yet been paid. Are you aware that banks and annuities do not count retainage as an asset when calculating receivable assets which results in subcontractors being unable to access alternative cash flow to make up for funds held up in retainage? So much about retainage that makes the practice obsolete. Read more in the HB21-1167 Fact Sheet included with this issue of the President's Message and watch your inbox for the CALL TO ACTION.
